Andover voters will be asked to vote on the proposed building of a new Bancroft Elementary School and two land-purchase transactions. Town meetings are an integral part of both Andover and North Andover's town government and they only work with voter participation. I encourage you to attend the upcoming special town meeting in your town and be a part of this uniquely New England process. Your vote counts!

The League encourages you to support the Bancroft building project. The existing school building and systems are at the end of their useful lives, the building is structurally unsound and overcrowded, access and traffic flow are below safety standards, the building is out of ADA and fire code compliance, maintenance costs are above average, and the building has incurred and will continue to incur significant expenses for structural band-aids. Please read the article below for an expanded review of the need for a new school, the process to this point and going forward, why timing is important, and proposed funding sources.

North Andover News

North Andover voters will gather for a special Town Meeting on Wednesday, November 17th. The Warrant Articles will include an article to consider purchasing two new fire trucks, an article to replace portions of the HVAC system at the Stevens Memorial Library, articles to finance the aforementioned capital improvement articles, and any citizen petition articles submitted properly by the warrant closing deadline.

After hearing the testimony of Fire Chief Melnikas and Library Director Mary Rose Quinn before the North Andover Finance Committee, I am confident that the citizens of North Andover will recognize the urgency of addressing these two departments' needs. There are several options

available to meet those needs, however, and any choice of equipment will require Town Meeting's approval to revise the FY2011 budget that we passed at the May Annual Town Meeting to pay for it. Town Manager Mark Rees has compiled more than one payment option that the Finance Committee will evaluate over the next few weeks. Both the Board of Selectmen and the Finance Committee will recommend action on both the purchase of equipment and how to pay for it either before or at Town Meeting. Presentations on how to finance these capital projects by revising the FY2011 budget ought to include information that voters can weigh on what the impact of reductions to the current budget will mean to individual departments.

Trying to meet capital needs while preserving municipal and school services requires maintaining an ongoing balance between what we need immediately and what we will need in future years. If skillful in maintaining that balance, we can avoid emergency needs down the line. Since North Andover doesn't have a dedicated savings account for capital needs, we use a five year capital improvement plan that keeps our debt service ratio typically in the 5% of operating funds range. When emergency needs erupt, the priority list of projects is adjusted to meet those needs. This process has served our town well, since we are careful to add only manageable additional debt as other debts fall off when payment has been completed. We've been lucky though - our emergency needs have arrived in manageable intervals. What happens though as our equipment and building assets age and our resources to replace and repair them dwindle? I'm reminded of the year my washing machine, dryer, stove, dishwasher and water heater all went within six months of each other. I had to replace them despite not having budgeted for this kind of appliance spending spree...and I'm now worried about them all reaching the end of their life span together in a few years...I do not want to get that déjà vu feeling in either my head or my wallet. If the Town of North Andover - and Sandy Glead - may be well served by starting that capital improvement dedicated savings account now with whatever reserve funds we can spare. It could save us all a lot of stress in future years.

Pat grew up in Wellesley, MA and is a second-generation League member as her mother was a member as well as a town meeting representative. She attended college at Mt. Holyoke receiving her degree in English with a minor in Philosophy. Pat's interest in politics and community were evident back then as she enjoyed

courses about Political Parties and Constitutional Law, including a working spring break in Washington, DC. For Pat, the trip's experiences were inspirational and "catalyzed her interest" in government, state functions and how important "working for the people" was.

Pat's League accomplishments began in the early 1960's with Voter Services, organizing the candidates' forum for local elections, as well as study units including enlarging the town library, educational issues, and the need for school libraries, among other study topics.

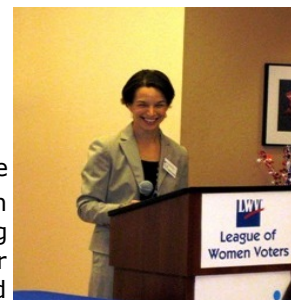

A pre-election event took place Sunday, October 24th at the North Andover Senior Center providing the opportunity for North Andover residents to meet face to face and



talk with several of the candidates running to represent the town at the State House. In attendance: Heather McNeil, member Kevin Begley (R) and Dave Torrisi (D) who are in the race for the 14th Essex House of Representatives seat representing precincts 1-6 and Barbara L'Italien (D) who is in the race for the 18th Essex House of Representatives seat representing precincts 7 & 8.



James Lyons (R), running against Barbara L'Italien, Steven Baddour (D) and Stephen Cole (R) running for the 1st Essex State Senate seat representing precincts 1, 4, 6 & 8, were invited but not in attendance. Bruce Tarr (R) running, unopposed, for the 1st Essex and Middlesex Senate Seat was also invited but not in attendance. 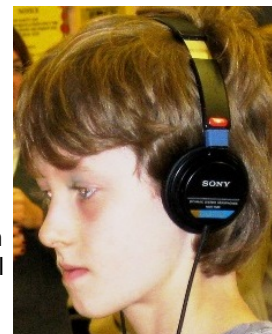

Bancroft School Building Project

Overview

At a special Town Meeting on December 6, 2010 Andover residents will vote on a proposed new Bancroft Elementary School building. If the warrant article passes, the proposal will go to a ballot vote at a special election on January 25, 2011. The League of Women Voters of Andover/North Andover encourages you to attend Town Meeting, go to the ballot box, and support the Bancroft building project.

The existing school building and systems are at the end of their useful lives, the building is structurally unsound and overcrowded, access and traffic flow are below safety standards, the building is out of ADA and fire code compliance, maintenance costs are above average, and the building has incurred and will continue to incur significant expenses for structural band-aids.

The Bancroft School project has been selected by the Massachusetts School Building Authority (MSBA) as part of a building program that will result in 40-45% of the cost of the new building being reimbursed by the State. However, we have a short window of access to these funds. If Bancroft does not take advantage of the grant the funds will be reallocated. Additionally, the proposed design of the school capitalizes on energy efficient elements and sustainability features which will result in operating cost savings and offer possibilities for best practices to be shared with other Town buildings and sustainability curriculum opportunities throughout the district.

The combination of structural need, funding availability, and sustainable design features present an opportunity that the residents of Andover should support. Please take advantage of the opportunities that will be available over the next several weeks to learn more about the Bancroft School building project (you will receive informational emails and invitations) and put the special Town Meeting on December 6 and the ballot vote on January 25 on your calendar.

Background

When the Bancroft School was built in the late 1960's, its architect was hailed as a visionary for creating an impressive and unusual design for a school (for those that don't know it is an open-concept interior with an exterior intended to evoke the vision of a castle). Since then, the Bancroft community has grown and elementary education has changed, creating the need for additional building space (for increases in population as well as to

accommodate growth and advances in special education and other programs) and a layout more conducive to the learning environment.

The current Bancroft School building has a design capacity for 356 students. Enrollment as of October 1, 2009 was 469. The Town has added modular classrooms to bring capacity to 453 students, however, this is neither a comprehensive nor long-term solution. Additionally, the current building is out of ADA and fire code compliance.

Because of its design Bancroft is costly to maintain. The average maintenance cost per square foot for Bancroft from 2003 through 2008 was \$7.89 versus \$1.83 for High Plain Elementary, which opened in 2002, an average of \$5.22 per square foot for elementary schools district-wide, and an average of \$3.74 per square foot excluding Bancroft and Shawsheen. The building has significant structural deficiencies and the majority of its infrastructure and systems are antiquated and beyond their useful lives.

Since 2005, Andover has spent \$1.8 million in special structural projects to keep the building safe on an interim basis.

These factors led to the formation, in June 2008, of a committee to study the physical needs of the Bancroft Elementary School and explore options for renovation or replacement. The Bancroft School Building Committee (SBC) (which is made up of Town and School District employees, a representative from the School Committee, and independent townspeople) has worked with Symmes, Maini & McKee, a reputable architectural firm with a specialization in school design, the Bancroft neighbors, "green" advocates, Bancroft staff and families, and anyone who wishes to have a voice (the SBC has regular public meetings) on the feasibility study and schematic design for which funds were approved at (and supported by the League at) the May 2008 and 2009 Town Meetings.

Through the studies it was determined that extent of the building's deficiencies and safety issues do not lend themselves to renovation and that replacement is the only viable option.

In 2008, the MSBA selected Bancroft as part of a building program in which a portion of the cost of the building is paid out of state building funds (more detail below). The MSBA has now approved the feasibility study and is currently reviewing, and expected to approve on November 17, 2010, the schematic document submitted on October 1, 2010.

The next step is for the townspeople to vote on advancing the project at a Special Town Meeting on December 6, 2010. As the Town's portion of the project cost will be financed via a debt-exclusion, assuming the project passes the Special Town Meeting, there will be a ballot vote on January 25, 2011.

The Proposed New Building

The proposed new building will have benefits for the students, staff, district residents, and the broader community. The building is intended to accommodate 680 K-5 students. This will help alleviate overcrowding in elementary schools throughout the Town of Andover. Town-wide, elementary schools are at 110% of capacity,

with only High Plain below capacity and Shawsheen (housing pre-K to 2 students) at the highest percentage of capacity at 170%. The capacity of the proposed school positions the Town with the option to accommodate the K-2 population of Shawsheen at Bancroft, relocate the pre-K students, then close Shawsheen which would save an estimated \$7 millions of dollars in required upgrade costs and high annual maintenance costs (\$8.51 per square foot versus a district-wide elementary school average of \$3.74 per square foot excluding Bancroft and Shawsheen) due to the age and condition of the building. Additionally, the building would provide increased capacity and functionality for in-district special education (SPED) programming whereby supporting and mainstreaming SPED students and saving the Town money on out of district programs.

The proposed new building's shape could be describe as a three story starburst so designed to minimize the external physical massing necessary to accommodate 680 students and to create an interior appropriate to elementary age students. Having sat in on many meetings I can attest that the SBC has made every effort to have the building fit nicely on the site, preserve existing vegetation, and accommodate neighboring properties. The building will sit just in front (to the north) of the existing building with play areas and fields to the back (south) of the school. A good deal of the existing mature trees and other vegetation will be preserved and will serve as a natural barrier to roadways and neighboring properties.

The site design includes adding a second access road (from West Knoll Road). Currently, there is only one access road to the school (from Bancroft Road), which is considered a safety vulnerability. All other schools in Andover have at least two access roads. The second access will improve both site safety by allowing additional access for emergency vehicles and traffic circulation by bringing traffic further into the Bancroft site and out of the surrounding neighborhoods.

The building will have facilities that have the potential to be used year round by the community including a full size gymnasium, improved soccer fields, and air conditioning allowing for use for summer school, summer athletic, and other programs. The building's design incorporates many "green" features which in addition to helping to create a sustainable design, reducing operating costs, and providing learning opportunities for children and others throughout the Town, allow the Town to recoup up to an additional 5% of the building cost from the State. There is a plan for 90% reuse/recycling of all materials in building and demolition and for the planting of hundreds of new trees on the site.

The current cost estimate (which is subject to adjustment) is approximately \$44 million including all contingency allocations. Excluding contingencies the estimate is approximately \$38 million. Of this figure, the Town will be reimbursed 40-45% by the State of Massachusetts per the above-mentioned MSBA designation mentioned above plus the additional up to 5% reimbursement for sustainable building features. In the event that the project does not move forward at the December 6 Town Meeting the availability of reimbursement funds is likely to be jeopardized as funds may be reallocated and Andover may

have to reapply to the MSBA program. Given the state of the economy and proposals for state sales tax reductions, new MSBA funds are highly uncertain. Additionally, while not ensured or necessarily quantifiable, the current state of the construction market and interest rates may be advantageous to the project on the current timetable.

Indicative Timeline and Information Resources

Assuming the project passes both the December 6 Town Meeting and the January 25 ballot vote, it is expected that site work would begin in June 2011 with build-out of the West Knoll Road access and construction of temporary fields, play space, and parking. Foundation and steelwork would likely begin in September 2011 followed by building construction in December 2011. The expectation is that the new school would be open for the start of the 2013-2014 school year. The final phase of the project would be to abate and demolish the existing building and complete final site work. All work is expected to be complete around July 2014.

The SBC meets regularly. Their meetings are open to the public and posted on the Town's website at www.andoverma.gov, the SBC website at www.aps1.net/index.aspx?nid=426, and at the Town Offices. The SBC's website also includes meeting agendas, minutes, presentations, studies and reports, and other project information. The Bancroft building project will be highlighted at Town of Andover Mid-Year Review, co-sponsored by the Town and the League, on November 16, and other opportunities to learn more about the project will be forthcoming. Celebrating the League's 90th Anniversary The Early Sixties

*This month's LWVANA history article comes to us from
Rusty Dunbar.*



By the nineteen-sixties, the Andover League had hit full stride benefiting both in size, from a spurt in the local population, and in stature, from our original sponsorship of a strong Town Manager charter. With a membership of more than 280, and increased visibility and credibility, the League had become a vibrant and well-oiled

participant in Andover affairs.

The League calendar had nine sets of units (with four sessions for each of the nine topics), an active Voter Service component sponsoring candidates' meetings, Town Meeting informational sessions, and even baby-sitting for Town Meeting itself.

Increasingly, members became hooked by their local League studies and went on to run for office or join Town committees. Jinny Cole was a classic example at the local level, serving as a School Committee member and later a Finance Committee member (perhaps the first female member). At the state level, our state president, Lucy Wilson Benson, was a real inspiration to all who knew her. She went on to lead the National League of Women Voters and later became Under-Secretary of Defense under President Carter.

The impact of the long years of study certainly left its mark locally: ongoing League support for the schools, special education, the library, and recreation and conservation services at almost every Town Meeting. Of particular note are the League's enduring support for our strong Town Manager charter and continuing effort to fine-tune Town Meeting rules and regulations. Years well spent!
