

North Andover News

It was very fun here in North Andover over the summer months as North Andover hosted several great community events that focused attention on what makes our town a great place to live.

Fourth of July weekend, the League of Women Voters greeted townspeople at our table during the Town's gathering on the common. It was a very hot day (haven't they all been hot this summer?), so special thanks to Heather McNeil for manning the table and to Kathy Stevens for dropping by to help as well. I hope some of you caught NACAM volunteer Gail Heney's live interview with us that ran on the cable stations that weekend.

Selectman Dan Lanen was elected the new chair of the North Andover Board of Selectmen. Rick Nardella was elected vice-chair, and Tracy Watson was elected Licensing Chair. One issue settled over the summer was the water and sewer rates: rates will remain the same as in FY2010, however the water and sewer revenue and expenses will be monitored quarterly and rate adjustments made if necessary. I certainly thought about the town's financial status in these accounts many times as I dragged out my hose to water my rain-starved perennials. I'm hoping the silver lining to the drought

conditions may be that the prospect of account deficits and rate increases diminished as consumption increased. I know I did my part based on the size of my water bill!

Another issue of concern to our town was/is what's happening next door in Lawrence with budget cuts to their Fire Department. Relying on mutual aid to cover for shortfalls in Lawrence's budget means that North Andover will be called upon to absorb the increased costs in overtime, wear and tear on our equipment, and potential injury liabilities that we will incur with mounting calls to respond to Lawrence fires. This also could result in reduced coverage within our own town's borders if our equipment is engaged in Lawrence when needed in North Andover. This issue is so important that North Andover has been cited in related news stories in print, radio, and televised coverage.

In closing, this fall will be politically exciting with both the upcoming primary and November ballots. Be sure to lend either an ear or a hand in League of Women Voters' activities leading up to these events.

Voter Service Update Pre-Primary Candidates' Forum

The state primary is September 14. Ten of the twelve candidates running for state offices in three races participated in the League of Women Voters of Andover/North Andover Pre-Primary Candidates' Forum on Monday, August 30 at Memorial Hall Library in Andover.

Republicans James J. Lyons, Jr. and John O. Thorlin are running for the 18th Essex District State Representative seat, which covers parts of Andover, Boxford, Georgetown, Methuen, North Andover, and Haverhill. Incumbent, Rep. Barbara L'Italien does not have a Democratic challenger in the State Primary and did not attend the forum.

Republicans Paul Adams and Salim R. Tabit, and Democrats Patricia Commane and Frank J. Bonet are running for the 17th Essex District State Representative seat which covers parts of Andover, Lawrence, and Tewksbury. Frank Bonet did not respond to the League's invitation.

Republicans Patrick Rahilly and Jamison Tomasek, and Democrats Barry Finegold, Debbie Silberstein, and John J. 'Jack' Wilson, Jr. are vying for the 2nd Essex & Middlesex District Senate seat being vacated by retiring Senator Sue Tucker, which covers Andover, Lawrence, Dracut, and Tewksbury.

The forum featured a segment for each legislative contest, with the candidates seated by party and answering questions submitted by the audience. Jo-Ann Berry, LWV of Acton Area, moderated the event. The forum aired on Andover cable channels 8 and 47 and was taped for rebroadcast during the two weeks before the September 14 State Primary election. The recording has been shared with local media stations in North Andover, Andover, and surrounding communities and will be aired leading up to the primary. A group of Andover High School students volunteered at the event, which was free and open to the public.

Know Your Town Fair

The annual Know Your Town Fair will be held Saturday, September 25, 2010 as part of Andover Days. Know Your Town Fair is an event led by the League of Women Voters of Andover/North Andover to provide nonprofit organizations an opportunity to network and engage people from Andover and surrounding communities in learning more about their organizations and to promote the organizations' upcoming activities.

Andover Days is being organized by the Andover Downtown Business Association (ADBA). In addition to Know Your Town Fair, Andover Days will feature exhibits by local businesses and organizations as well as concerts, fashion shows, and other events.

Space is available for Know Your Town Fair participants on Park and Barnard Streets for \$20 or on Main Street for \$75. For the Park and Barnard Street spots participants bring their own table, chairs, and canopy if desired. For the Main Street spots a canopy will be provided including set up and take down. All space is available on a first-come first-serve basis. The ADBA would like exhibitors, particularly those on Main Street to consider having a craft, game, or some other activity to draw people to the event early in the day.

The League recognizes that \$75 is a high participation fee for nonprofit organizations. If you would like to be on Main Street but want to minimize the cost, consider sharing the space and cost with another organization. Foot traffic on Park and Barnard Streets is typically strong during the event as people park in the municipal parking lots and walk to Main Street so the tables on these street should also have good exposure.

The League has actively worked to keep the cost of participating in Know Your Town Fair accessible for all nonprofit organizations. We realize that the cost has increased over the years but hope that one of the options presented this year will work for all interested organizations. Primary reasons for the increased cost this year are changes in corporate sponsorship structure (with sponsors working directly with River 92.5FM and not making the same donations to

ADBA) and charges from the Town for police details, ambulance presence, custodians, and clean up crews.

LWVANA History Committee

In honor of the LWV's 90th anniversary, a group of LWV members, many from the 60's and 70's, who are interested in the history of the Andover/North Andover League has been meeting to rediscover the excitement of the women's suffrage movement that took place in our town from 1912 to the founding of Andover's LWV in 1920. The group is also reviewing its history since then, focusing on each of the decades of the LWV's 90 years.

The efforts of the League have brought about effective change and have provided Andover and North Andover with many of their innovative strengths -- kindergartens in the public schools, libraries in the schools, the building of new schools to accommodate growing populations, the town manager form of government in Andover, the planning board and an effective system of zoning regulation, recreation programs, recycling and the present trash and recycling program, and preservation of open space.

Here are some tidbits of our early observations. Dues in the early Equal Suffrage Association were 50 cents a year. Current LWVANA dues are \$55 a year. In the early years the women met in Phillips Academy buildings or faculty homes during daytime hours. Today most meetings are held in members' homes or in Memorial Hall Library. To accommodate today's career women's schedules many meetings are held in the evenings or sometimes over lunch at Panera.

Through the years, The Andover Townsman, League *Bulletins* and yearbooks have documented the activities of the yearly schedule - meetings, consensus units, public forums. Today all is found online as well. The Andover league attracted 400 members in 1925. Today, with so many women in the work force, there are about 135 members in the combined Andover/North Andover League, including several men.

The committee is authoring articles on different aspects of the history of the 90 years of the LWV and will plan to celebrate the "birth" of the Andover league at the December meeting.

Keep Informed, Stay Engaged, and Take Action for North Andover Schools

I taught for almost nine years before being at home with my daughters. My eldest is entering the North Andover Public Schools this fall as a kindergartener so I am well aware that with September comes the start of school. But it is also the beginning of many opportunities to be an advocate for public education.

When I was teaching, I paid a great deal of attention to my students, my classroom, and the school in which I worked. Given that I didn't live in the town in which I taught, I paid little attention to decisions being made at the town level and even less attention to the happenings at the state and federal levels. Since I have some time now before I return to work, I have chosen to spend time at school committee and other local meetings, League of Women Voters meetings, and with Stand for Children, an education advocacy group at the state level, learning about the decision making processes that take place that ultimately affect our schools, our classrooms, and our children. The experiences have been an education for me as a teacher and as a parent.

So, I am urging people to explore opportunities to get educated and involved. It can take as much or as little time as you have. You can attend a meeting or watch one on television, watch the news or debates, or sign up with one of the various organizations that advocate for schools and for our towns to receive e-mails and information. You can hold signs at the polls, write letters to the editor, vote, and contact or visit elected officials.

Our elected officials want our input and are happy to answer questions, address concerns, hear solutions, and find out from us what is working well. Below, you will find information on whom to contact (subject to change due to fall elections) and a list of some organizations you may want to check out if you are interested in learning more about all the issues that affect our schools and our children. You will also find a tentative North Andover School Committee meeting schedule. I am hoping that this list makes staying informed and taking action easier and less time consuming.

Form Based Zoning Code Moving Forward

Early June saw the initial release of the Tri-Town Area Form Based Code which is intended to regulate all development that will result from the new interchange in the Lowell Junction Area. In developing this code, the towns and consultants, VHB, have identified six "character areas" within the 700 acre development area (see page 7 of the Draft Form Based Code for more details.) Each Character area is defined by its constraints, desired ambiance, and desired function as defined by each town via the charettes held last winter. For each of those character areas, VHB has developed a "kit of parts" defining building height and form, roadway criteria, open space criteria, parking criteria, and use restrictions. Using this "kit of parts" approach, the towns hope to provide great flexibility for developers long into the future while maintaining the look and functions each town desires. Needless to say, this is a tremendous undertaking requiring each town to scrutinize not only the details in each "kit of parts" but also the big picture of each character area.

At this point, the towns have received initial feedback from the public, landowners, town planning boards, and other organizations. In addition, the Tri-Town Task Force has decided to solicit further feedback in the form of a market analysis study to assess the development potential of this code. The Tri-Town Task Force is also planning on revisiting each of the stakeholders for more detailed feedback. Once the study is completed, it will be combined with all the feedback into a second draft of the code. This draft is expected to be available in the fall at which point, public feedback will again be solicited.

On a parallel track, the development of the ramp design is proceeding. MassDOT and their consultants, AECOM, have been assessing each potential ramp design against the criteria defined in the Draft Environmental Impact Report. They will be holding a public meeting in the fall to review their analysis - the date has not yet been set. Their goal is to put forth a preferred design alternative to the Federal Highway Administration this fall.

LWVANA Nonpartisan Guidelines

At the August 11, 2010 board meeting, the League of Women Voters of Andover/North Andover re-adopted its nonpartisan guidelines as presented below.

Local, state and national guidelines

The following restrictions and permissions apply to activities on the local, state and national level.

League President and Voter Services Chair

The President and the Voter Services chair MAY NOT:

- Circulate nominating petitions.
- Endorse a candidate.
- Display a candidate's yard sign.
- Attend or host a political function held for the purpose of introducing or fundraising for a candidate.
- Make a campaign contribution to a candidate (either above or below the reporting level)

- Run for a local charter commission.
- Run for elective office, whether partisan or nonpartisan.
- Serve in any position in a political party.

The President MAY NOT:

- Accept an appointment to a local commission, board or committee if such service would be in conflict with the League's program. This restriction does not apply to the Voter Services chair.

The President and Voter Services chair MAY:

- Sign nominating petitions, whether partisan or nonpartisan.
- Attend informational campaign functions to which all candidates have been invited.
- Accept an appointment to a local commission, board or committee if such service would not be in conflict with the League's program.

All other League members

Apart from the restriction given below about displaying LWV yard signs, no restrictions are placed on the political or civic involvement of all other League members, as long as they are not representing the League during this involvement. Any questions should be brought to the League board.

The following restriction applies to all LWV ANA members and non-members: Any political yard sign, including candidate's signs, ballot question signs, or warrant article signs, may not be simultaneously displayed with a League get-out-the-vote sign.

Political activity of spouses and relatives

The political activities of a spouse or relative of a League board member are considered separate and distinct from the activities of the board member. However, the President and Voter Service chair must keep in mind that their impartiality may be called into question if their spouse engages in high-profile political activity, such as running for elective office.
